WORKSHOP MEETING MINUTES

January 11, 2016

CALL TO ORDER:

President Matthew Doebler called the meeting to order at 7 PM with the Pledge of Allegiance and roll call. Those in attendance were Vice President George Jones, Commissioner Arthur Williams, Solicitor Chris Lovato, Manager Gwen Patterson and Secretary Kimberly A. Koskey. Commissioner Joanne Schollaert was not in attendance.

MINUTES:

Commissioner Williams made a motion to approve the December 21, 2015 Legislative Meeting minutes and the January 4, 2016 Reorganization Meeting minutes. Vice-President Jones seconded the motion. The motion passed unanimously.
