LEGISLATIVE MEETING MINUTES

December 21, 2020

CALL TO ORDER:

President Jones called the meeting to order at 7:00 p.m. with roll call. Those in attendance were Vice President Arthur Williams, Commissioner Daniel Darragh, Commissioner Amy Richert, Commissioner Judy Haluka, Solicitor Harlan Stone, and Manager Gwen Patterson. and Secretary Patty Krecek was not in attendance. The meeting is being recorded and conducted remotely using video communications.

EXPLANATION OF MEETING FORMAT:

Solicitor Stone said the Board is meeting under the guidelines established by the governor and the Commonwealth of Pennsylvania for public meetings during the COVID-19 crisis.

MINUTES:

Commissioner Darragh made a motion to approve the December 14, 2020 Workshop Meeting Minutes. Vice President Williams seconded. The motion passed unanimously.

REPORTS

POLICE:

Ohio Township Chief Joseph Hanny gave his report for the month of November. There was a total of 70 calls, which included 42 EMS assists and some citations. The report was accepted.

FIRE:

EMERGENCY MANAGEMENT:

Commissioner Haluka stated that hospital personnel have started to receive the COVID-19 vaccination. Masonic should start receiving the vaccination within three weeks. The report was accepted.

TAX COLLECTOR/TREASURER:

Treasurer Steup gave the report for the month of November. The report was accepted.

FINANCE:

Commissioner Haluka made a motion to approve the November bill list in the amount of \$31,902.18; to ratify November pre-paid bills in the amount of \$19,960.37; and to ratify November payroll transfers in the amount of \$15,616.45. Commissioner Darragh seconded. The motion passed unanimously.

Commissioner Darragh made a motion to adopt the 2021 Real Estate Tax Rate Ordinance. Vice President Williams seconded. The motion passed unanimously.

Commissioner Darragh made a motion to adopt the 2021 Budget Ordinance. Commissioner Richert seconded. The motion passed unanimously.

Commissioner Darragh seconded the motion. The motion passed unanimously.

ALEPPO TOWNSHIP AUTHORITY:

Commissioner Darragh stated that at the ATA's meeting last week the 2021 water budget was adopted. There is no rate increase. The 2021 sewer budget was tabled because additional information is needed. Commissioner Darragh also stated that the alarm issues at the pump stations are being investigated and there will probably be a \$50,000 cost for improvements to the alarm system.

QUAKER VALLEY AMBULANCE AUTHORITY:

Commissioner Haluka stated there were 175 billable ambulance calls in October, which is an increase of 45 trips compared to 130 trips from the previous month. Commissioner Haluka also stated that there were some capital improvements, which included re-paving the parking lot, and operations have not been affected by COVID. The report was accepted.
