Any work proposed for street opening or pavement cuts within the right of way of a Township road requires submission of three (3) copies of this form along with three (3) copies of a sketch showing location and details of the proposed work, and proposed driveways shall submit two (2) copies of this form and of all plans as required by Section 4.1.3.B of Ordinance #193.

Any work performed on a Township road, over, under, or within, the limits of a limited access state highway requires a state permit.

The prescribed permit fee shall accompany the application and sketch. Schedules of fees are furnished on request.

Immediately upon completion of the work as stated in this permit, the applicant shall notify the Township.
